During national Safeguarding Adults Week, East Riding and Hull Safeguarding Adults Boards are joining forces with the Ann Craft Trust to support the campaign to come together to raise awareness of important contemporary safeguarding issues.

The week will enable more organisations and individuals to feel confident in recognising signs of abuse and neglect and reporting safeguarding concerns.

# **Health Bus**

As part of the week the Public Health Community bus will be visiting towns within the East Riding.

Safeguarding experts from City Health Care Partnership (CHCP) will be available to talk about safeguarding issues and have leaflets available regarding support.

East Riding Voluntary Action Services (ERVAS) has recently been commissioned by East Riding of Yorkshire Council to:

- deliver the East Riding VCSE (voluntary, community and social enterprise sector) Safeguarding Support Service
- undertake the East Riding Domestic Abuse VCSE Lead Representative role

The aims of both projects are to provide additional support and information to all VCSE groups and organizations working with children, young people and adults across East Riding, including the faith sector, in order to ensure they are able to meet their safeguarding responsibilities and keep people safe, as well as ensure their beneficiaries have access to appropriate support at the earliest opportunity.

To do this, ERVAS will do the following:

- Provide individual support to East Riding VCSE groups and organisations
- Find out more from the VCSE about what they would like in order to meet their safeguarding responsibilities
- Develop the Keeping People Safe section of the ERVAS website: <u>https://ervas.org.uk/keeping-people-safe/</u>
- Provide a range of practical support such as Safeguarding Children and Adult policy templates, DBS checks
- Work with partners to develop a strong training offer to the VCSE based on their needs in regard to keeping people safe
- Support with challenge or 'troubleshooting'
- Increase partnership working across the sectors in relation to keeping people safe
- Provide representation of the VCSE interests on the East Riding Safeguarding Children Partnership; East Riding Safeguarding Adults Board; East Riding Domestic Abuse Strategic Board; East Riding Community Safety Partnership and relevant sub-groups
- Work with appropriate agencies and organisations to grow additional services and increase resources within the VCSE to keep people safe in East Riding
- Work closely with relevant partners to ensure a coordinated approach to supporting the VCSE and their beneficiaries

To achieve each of the objectives above, ERVAS has recruited the following additional members of staff to ensure the successful delivery of the projects.

#### View DVAP Resources

Humberside Fire and Rescue Service are re-branding their domestic fire safety visits. We will still be offering interventions and signposting around health and wellbeing for those we visit but our new name: Home Fire Safety Visit, places the emphasis squarely on our primary aim to promote fire safety in the home.

Home Fire Safety Visits are available for those most vulnerable in our community such as those with mobility, hearing or visual impairments. Agency staff or family members can make referrals for anyone they are concerned about with their consent through our website: <u>www.humbersidefire.gov.uk</u>. We also take self-referrals, through the same route, from anyone wanting advice on preventing fires or escape planning.

# ERSAB Training

ERSAB training continues to offer free safeguarding adult training to independent social care providers, most of which is virtual.

Training is also provided for Board Partners on request.

The full suite of ERSAB virtual training includes Level 1 (Recognising Adult Abuse), Level 2 (Reporting Concerns and Mental Capacity Act) and Level 3 (The Role of the Manager and S42 Enquiries as well as Provider Support, Quality Improvement and Organisation Safeguarding Procedure Awareness briefings). Level 1 Recognising Adult Abuse is also available as e-Learning and Workbook.

Please note that after the end of this year Mental Capacity Act (MCA) training will, temporarily, only be available via eLearning, pending a revision of the L2 MCA course once guidance is published on the Mental Capacity (Amendment) Act 2019 and Liberty Protection Safeguards (LPS) (which will replace Deprivation of Liberty Safeguards (DoLS)). Details about accessing the MCA eLearning course will be available on the ERSAB website shortly.

Early in October we held a two-day course for those wanting to be Cascade trainers and it is anticipated that a further course will be offered in spring 2023 depending on interest. Please contact us if you are interested.

The current training calendar runs until Christmas 2022 and the calendar for winter/spring 2023 will be released towards the end of the year. Click on the link below for details and dates.
